BWC Activated

This investigation was completed without reviewing any BWC footage, per departmental policy and guidance.

On Friday, July 5, 2024, at approximately 17:11 hours, Officer Brian Ayala (RO-1) was in full uniform and operating a marked police bicycle when a radio run went out through USCP Communications of two officers actively fighting with a subject; later identified as James, Walter (S-1); that had jumped the bike racks on the Lower West Terrace of the U.S. Capitol. RO-1 responded to the scene and observed Officer Akim Cobham (AO-1), Officer Jarvis Franklin (AO-2), Officer Jeffrey Moyer (AO-3), and Officer Joseph Martorano (AO-4), actively fighting with a subject on the south steps of the Lower West Terrace. AO-1, AO-2, AO-3, and AO-4 were attempting to get S-1's hands out from underneath his chest. RO-1 observed that S-1 was lying prone, face down on the landing and was shouting at no one in particular. AO-1, AO-2, AO-3, and AO-4 were able to secure S-1 in handcuffs and escorted S-1 down the steps to the Lower West Terrace.

AO-1 and AO-2 advised that they both observed S-1 jump over the bike racks on the Lower West Terrace which clearly mark the steps as a restricted area. AO-1 and AO-2 instructed S-1 to return to the other side of the bike racks but S-1 refused and continued to walk up the south steps of the Lower West Terrace. AO-1 and AO-2 attempted to grab S-1's arms to physically stop S-1 from continuing up the steps, S-1 actively pulled his arms back and withdrew from AO-1 and AO-2 to avoid them. As S-1 pulled his arms back, S-1, AO-1, and AO-2 fell to the ground and were actively struggling on the steps. AO-1, AO-2, AO-3 and AO-4 were able to detain and place handcuffs on S-1. RO-1 assisted with the search of S-1 once they were detained and secured any property that belonged to S-1.

S-1 was placed under arrest for Unlawful Entry, Resisting Arrest, and Assault on a Police Officer. S-1 was transported to 119 D Street for Processing. CIS special Agent O'Neil was notified.
