## **BWC** Activated

The offense occurred on Wednesday, July 10th, 2024, at the location of 890 23 Street Northwest, Washington, D.C. (PSA 207) at approximately 0825 hours. Officer Botlero was operating as a 10-99 unit under call sign 2071D operating marked cruiser 2061 in full MPD uniform.

On Wednesday, July 10th, 2024, Officer Botlero was dispatched for an Fight at the location of 890 23 rd Street Northwest, Washington, D.C.

Upon MPD arrival on scene, the undersigned officer contacted V-1 and noticed DEF James was detained by Allied Universal Security Officer Delshawn Phillips (SPO# 32891).

V-1 reported to the undersigned officer that he was on his way to work as usual by the park area next to Geoge Washington University Hospital. V-1 also stated that he knows the surrounding area is highly homeless individuals and mental health consumers. As V-1 was walking out the park area, DEF James came around and started punching V-1 multiple times on his face without saying any words. DEF James continued to assault V-1 as they both went down on the ground.

V-1 also reported that after was he was punched 5-6 times on his face, DEF James started saying, "You are not the real Jewish and you guys are murderer, you guys kill people in Gaza and in America." DEF James continued to say racial stuffs to V-1. V-1 believes DEF James referred V-1 as Jewish because he was wearing his yamaka on his head. Special Police Officer Phillips from George Washington University Hospital arrived on scene and detained DEF James.

W-1, who was standing near by reported to the undersigned officer that she witnessed DEF James came around and started to fight with V-1.

Once MPD arrived on scene, DEF James was stopped and detained by the undersigned officers at the location of 890 23<sup>rd</sup> Street NW, WDC inside the park area.

V-1 positively identified DEF James as the person who punched him multiple times on his face and started saying racial slur.

Ambulance 23 arrived on scene.

V-1 sustained minor injuries to his face and minor laceration to his right elbow. V-1 was treated on scene and refused to transport to the hospital. V-1 advised he will go to the urgent care on his own.

DEF James also sustained minor laceration to his right knee. DEF James also refused further medical assistance.

Based on the preliminary investigation and witness testimonial statement, DEF James was placed under arrest for Simple Assault and Hate Bias Crime.

DEF James was identified by Texas Driver License as Walter Warren James with DOB: 06/13/1986.

DEF James was transported to the Second District for processing by the MPD undersigned officer. Unless immediately arrested, the DEF James would have continued to assault V-1.

Case closed with arrest of Walter Warren James with DOB: 06/13/1986.

The event and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.
